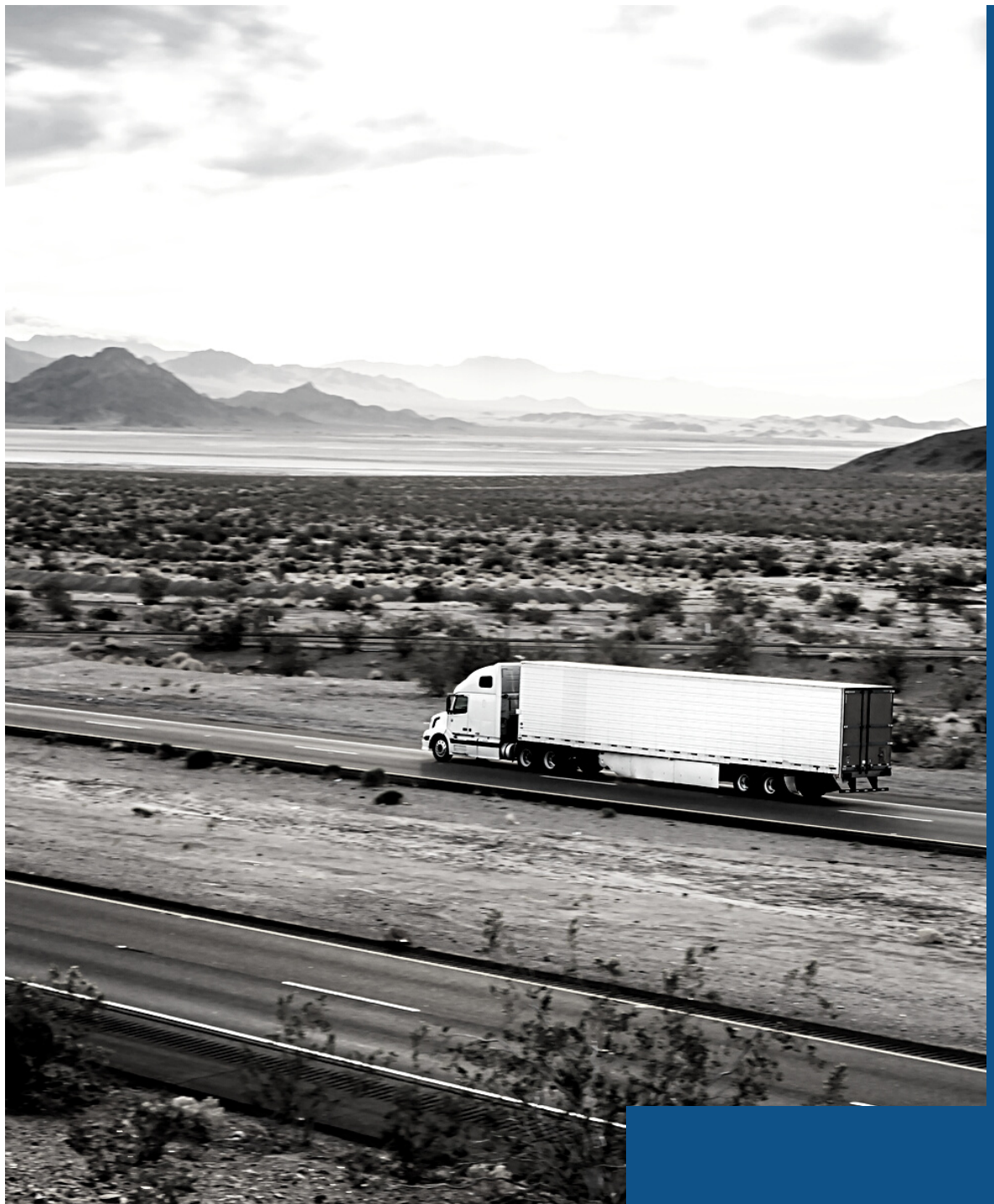

FINANCING FAQ

OUR FINANCE AGREEMENTS WITH CAPITAL PREMIUM FINANCE ARE AS UNIQUE AS A \$2 DOLLAR BILL.

DOES COVER WHALE ACCEPT 3RD PARTY FINANCING?

Yes, we accept third party financing however corporate guidelines require all AL policies be financed through Cover Whale.



CAN THE INSURED PAY IN FULL?

Yes an insured can pay in full if not financed through a 3rd party.

WHO COLLECTS THE DOWN PAYMENT?

Agents will collect all the down payments and retain the funds towards the commission to the agent. If the amount of the down payment is less than the amount due in commissions, Cover Whale will send the remaining commission amount directly to the agent.



WHEN ARE COMMISSIONS RELEASED?

Commissions are released within 30-45 days. For policies not financed through Cover Whale the agent can net out commission on future disbursements.

CAN I CHANGE DOWN PAYMENT OR APR TERMS ON FINANCE AGREEMENT?

Finance agreements are optimized to reduce cancelations and simplify payment terms for our clients.
